

Online Application for Chief Minister Relief Fund

(Only for Public Representatives) :-

While making online application for cmrf, need Desktop, Scanner, Printer and Barcode scanner (Optional).

Following are the mandatory documents for process the online CMRF application. Further some documents mentioned like (to be upload) should be scanned and upload online.

- 1) Applicant requisition Form along with photograph (to be uploaded).
- 2) Aadhar Card of the applicant.
- 3) White Ration Card / Income Certificate (to be uploaded)

If Patient is Child case:-

- 1) Guardian Aadhar Card
- 2) Birth Certificate (to be uploaded)
- 3) Guardian Bank Account Details (to be uploaded)

If patient deceased case.

- 1) Death Certificate (to be uploaded)
- 2) Family Members Certificate (to be uploaded)

For Medical Reimbursement case:-

- 1) Discharge Summary in **Original**. (to be uploaded)
- 2) Consolidate cash bills of the treatment, medicines etc.,
- 3) Final Bill in **Original** (to be uploaded)
- 4) Cash payment receipts to the Hospital in **Original**
- 5) Copy of Bank Pass Book having Account details along with Barcode of the Bank. (to be uploaded)

For Letter of Credit (LOC case) :-

- 1) Essentiality and Certificate (to be uploaded)
- 2) Emergency Certificate Hospital (to be uploaded)
- 3) Reports for evidence (to be uploaded)
- 4) A letter from the Hospital that the treatment is to be done through letter of Credit. (to be uploaded)

Step 6:- The said letter along with the documents uploaded and other necessary documents tagged properly and submit the said document to the Chief Minister's Office for further course of action.

Step 6:- After physical receipt of the document, CMO will recheck the entire application and provide a permanent CMRF number and process for further action.
